**OVINE BRUCELLOSIS-FREE (RAM FLOCK) ACCREDITATION SCHEME**

Your property has been inspected and found suitable for accreditation purposes, and all required tests have now been completed.

As a result, your name has been added to the list of owners of accredited ram flocks. Your certificate of accreditation is enclosed.

Your next test will fall due in **November 2023**. All rams on the property over the age of twelve months (including teasers) which you have used or are intending to use should be tested. If you wish to vary the time of this test, please contact me.

I remind you of the conditions of the signed accreditation agreement, especially (1) that any rams introduced from non-accredited flocks should be isolated and tested twice over 60 days, and also (2) that your accredited rams must not run on a property that has not been inspected and approved for accreditation purposes. Most accreditation failures involve one of these two issues.
