Your next test will fall due in November 2024. All rams on the property over the age of twelve months (including teasers) which you have used or are intending to use should be tested. If you wish to vary the time of this test, please contact me.

I remind you of the conditions of the signed accreditation agreement, especially (1) that any rams introduced from non-accredited flocks should be isolated and tested twice over 60 days, and also (2) that your accredited rams must not run on a property that has not been inspected and approved for accreditation purposes. Most accreditation failures involve one of these two issues.
